1. **Eligibility Criteria:**

Bidders who fulfil the following requirement shall be eligible to apply.

- a. The bidder shall have a valid Class B or above contract license supplied by KSELB.
 - b. The Panel shall have CPRI type test certificate for short circuit rating, temperature rise and IP classification for similar panels.
 - c. The Bidder shall have valid GST registration.
2. The time for completing the work shall be 60 days from the date of issue of work order. The materials shall be delivered at Rubber Park located at Irapuram Village in Kunnathunadu Taluk of Ernakulam District in Kerala State.

7. *Earnest Money Deposit (EMD) of the unsuccessful bidders will be refunded without any interest on finalization of the contract with the successful bidder.*
8. *EMD deposited with the client will be forfeited / encashed under the following circumstances.*
- *If the bidder withdraws his bid during the firm period specified.*
 - *If the successful bidder fails within the time limit to sign the contract agreement or fails to furnish the required performance security deposit.*
9. The bid submitted is treated as invalid if the bidder does not submit all the documents (as stipulated in the bid document).
10. The Managing Director, Rubber Park India (P) Ltd., does not bind itself to accept the lowest or any other bid and reserves to itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the

assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.

11. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable for rejection.
12. The Managing Director, Rubber Park India (P) Ltd., reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.
13. The contractor shall not be permitted to bid for supply if he/she is the near relative of an officer of Rubber Park India (P) Ltd.
14. The bid for the work shall remain open for acceptance for a period of 45 days from the date of opening of bids. If any bidder withdraws his bid before the said period or issue of Work order, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to Rubber Park India (P) Ltd., then Rubber Park India (P) Ltd. shall, without prejudice to any other right or remedy, be at liberty to forfeit 100% of the said earnest money as aforesaid. Further the bidders shall not be allowed to participate in the rebidding process of the Work and will be blacklisted.
15. The intending bidders shall ensure that the equipment offered are fully met with the technical specifications mentioned in the tender.
16. The intending bidders have to quote their corresponding item rates in schedule of quantities along with the price bid. The quoted price will be considered as all-inclusive rate inclusive of cost of transportation, packing, freight and insurance charges, all overheads, contingencies, profits, taxes (ie. Income tax etc.), duties/ levies, loading and unloading charges etc. for supply, installation, testing and commissioning of the equipment at the site of Rubber Park India (P) Ltd, Irapuram, but only exclusive of GST. The rates quoted by the Contractor shall be firm throughout the contract period and there shall be no upward revision of the rates quoted by the Contractor for any reasons whatsoever.
17. The successful bidder on receipt of the Work Order, shall deposit an amount equal to 5 % (Five percent) of the contract value, as Performance Guarantee in the form of DD in favor of **the Managing Director, Rubber Park India (P) Ltd. payable at Valayanchirangara** or online transfer to the account (**Account No. 57042660807, Name of Account holder: Rubber Park India (P) Ltd., Bank & Branch: State Bank of**

India, Valayanchirangara., IFSC Code: SBIN0070558) within 7 days from the date of Work order/letter of award and the deposit will be retained till 90 days after the expiry of the warrantee period/Defect liability Period. On completion of warrantee Period, the Engineer-in-Charge of Rubber Park shall recommend on demand from the bidder/Contractor to refund to him the Performance Guarantee and the same will be refunded/ released by the Accepting Authority provided that the Engineer-in- Charge is satisfied that there is no defect/liability outstanding against the bidder/contractor. All the deposits of EMD, security deposit / performance guarantee will not bear any interest whatsoever.

18. The successful bidder should provide warranty for 12 months from the date of supply, installation, testing, commissioning and handing over to the Engineer in charge of the work. The bidder should submit the warranty certificate along with the equipment in favour of the Managing Director - Rubber Park India (P) Ltd.
19. The successful bidders / contractor, on acceptance of his bid by the Accepting Authority shall within 7 days from the date of work order/letter of award, sign the contract in Rs. 200 worth Kerala Stamp paper consisting of the notice Inviting Bid, all the documents including additional conditions, specifications and drawings, if any, form part of the bid and the rates quoted at the time of submission of bid and acceptance thereof together with any correspondence leading thereto.
20. If the successful bidder fails to complete the work on or before the contract, he shall, without prejudice to any other right or remedy available under the law to the Government on account of such breach, pay as agreed compensation the amount calculated at the rates 1% per week or part of the week on the total contract value of the order subject to a maximum of 10% of the contract value. The successful bidder shall not be liable for delays in performing his obligations resulting from any force majeure cause as referred to and/or defined below.

Force majeure is herein defined as any cause which is beyond the control of the Contractor or the Employer as the case may be, which they could not foresee or with a reasonable amount of diligence could not have foreseen and which substantially affects the performance of the Contract, such as:

- a. Natural phenomena, including but not limited to floods, droughts, earthquakes and epidemics;
- b. Acts of any Government, domestic or foreign, including but not limited to war, declared or undeclared, priorities, guarantees, embargoes.

Then upon the happening of any such event causing delay, the contractor shall within

07 days give notice thereof in writing to the authority, but shall nevertheless use constantly his best endeavors to prevent or make good the delay and shall do all that may be reasonably required to the satisfaction of Rubber Park India (P) Ltd, to proceed with the work.

21. Payment Terms for Supply & Installation

Payment shall be released within 15 days after successful completion of the supply, installation, testing and commissioning and handing over of the total item against the submission of the factory test report, routine test report and GST invoice. The GST portion of the invoice would be released only after reflection of GST amount in our GSTR 2B.

Annexure-1: Technical Specification for MCC Panel for 30 HP Pump

All switchgears shall be fully rated at an ambient temperature of 40°C. All the switch boards are to be factory assembled, fabricated by a firm having CPRI type test certificate for short circuit rating, temperature rise and IP classification for similar panels.

A. Scope of work

Supply installation testing and commissioning of LT Panel, cubicle type, made out of 2mm thick CRCA sheet, totally enclosed, IP 42, free standing, floor mounting, dust and vermin proof, indoor, compartmentalised, suitable for operation on 3 phase, 415 V, 50Hz AC system with busbars, including internal wiring with suitable size HFFR wires/cable, interconnection, duly powder coated with seven tank process etc. The panel shall be fabricated from a firm having CPRI certification with test certificates for similar panel (required for short circuit rating, temperature rise and IP classification) and with following switchgears, metering instruments and accessories etc. complete as required as per drawing & specification. Incomer- 125 A, FP 36kA, MCCB with thermal based adjustable release with OL & SC protection - 1 No. Instruments (0 to 500) V, Voltmeter for 3 phase 4 wire operation with selector switch , (0-125)A ammeter for 3 phase , Resin cast CT (125/5, 0.5s), 2A SP MCB , LED indication lamps - RYB etc., as required complete as per Single Line Diagram. Busbar- 125A TPN busbar chamber with Aluminium busbar, Outgoings- 50 A TP MPCB - 3 Nos, STAR DELTA STARTER for 3 phase, 50Hz motor of 30 HP capacity with ON/OFF LED Indication lamps, Start / Stop push buttons, TP OLR with SPP, TP AC3 duty contactors, Auto/manual selector switch, contactor for A/M etc. - 2 Nos, 32A, 25 kA, 4P MCCB with ROM and spreader Terminal- 1 No. as outgoing and Space provision for one number of spare star delta starter for 3 phase, 50Hz motor of 30 HP capacity. The panel shall be with top/bottom entry to receive incoming & outgoing cable, all necessary interconnection & accessories as per particular specification & single line diagram. The panel shall be floor mounting with Fabricated metal stand of dimension 500 X700 mm (HXW). The scope is inclusive of the cost of all materials, dismantling of existing panels at pump house, consumables, labour, hire charges for all machinery, transportation,

insurance charges, all overheads, contingencies, profits, taxes (ie. Income tax etc.), duties/ levies, loading and unloading charges etc. complete as per the direction of Engineer in Charge. (Excluding GST).

B. Switch Board Construction

The switch boards are to be manufactured / assembled as per the latest BIS/IEC specifications, IP42 classification for indoor duty. The panel shall be floor mounted, free-standing type, suitable for indoor installation in dust, vermin proof construction and extensible type. The design shall include all provisions for safety of operation and maintenance personnel. The general construction shall conform to IEC 61439.

C. Housing Details

The Switch Board shall be fabricated out of 14 SWG (2mm) CRCA sheet for frame and 1.5mm for door and internal partitions (except load bearing members). It shall be provided with hinged doors on the front with necessary handles and earthed using flexible copper conductor. The doors shall be provided with neoprene gaskets. Suitable channel base frame should be provided for the panel board. Detachable gland plates of 3mm thick shall be provided at the bottom and top of the cable chamber, suitable for the termination of cables with compression type glands to the sizes as specified. Adequate space should be provided in the cable chamber for safe bending and termination of runs of cables and size as required. The enclosure shall be provided with lifting hooks, supporting legs and double earth terminals with double washers. The switch board shall be in cubicle design (each feeder components are housed in individual cubicle) and fully compartmentalized having total segregation between each cubicle. Suitable cable and busbar alleys shall be provided. All components of the switch board shall be approachable from front. The Busbar chamber cover should be bolted type. Supporting arrangement for dressing of power and control cables in cable alleys also shall be provided. The front openable/lockable door shall act as a cover for the switch boards. When door is open no live parts are accessible from the front door open case. The busbar should be extendable at both ends. No busbar should be protruded in the cable alley. General construction shall employ the principle of compartmentalization and segregation for each circuit. Unless otherwise approved, incomer and bus section panels or sections shall be separate and independent and shall not be mixed with sections required for feeders. Overall height of the panel shall not exceed 2.4 meters. The general arrangement and design of panels shall be got approved by RPIPL before fabrication. Cable entries for various feeders shall be from bottom. All cable terminations shall be through gland plates. There shall be separate gland plate for each cable entry so that there will not be dislocation of already wired circuits when new feeders are added. Cable entry plates shall therefore be sectionalized. The construction shall include necessary cable supports for clamping the cable in the cable alley or rear cable chamber. Necessary Eye bolt shall be designed and provided in the panel to take the dead load and dynamic loads during the unloading of the panels.

D. Powder coating

All metal sheets shall undergo 7 tank metal treatment for CPRI approved panel thorough degreasing, water rinse, de rusting, water rinse, phosphating, water rinse and then passivation. All metal surfaces shall be thoroughly cleaned and degreased to remove all scales, rust, grease and dirt. Fabricated structures shall be pickled and treated to remove any trace of acid. The undersurface shall be made free from all imperfections before undertaking powder coating. The colour of the Panel shall be colour of paint light Gray to shade RAL 7035; however, the contractor shall obtain details of approved colour from the Engineer-in-charge before powder coating. Panel finish shall be free from imperfections like pin holes, orange peels, run-off paint, etc. All unpainted steel parts shall be cadmium plated or suitably treated to prevent rust, corrosion, etc.

E. Busbar sizing connection and supports:

The busbars shall be made from high conductivity electrolytic grade aluminium alloy conforming to IS 5082. The busbars and supports shall be capable of withstanding the rated and short circuit current as per the single line diagram/ feeder details. Minimum size of main power bus bars shall be of incomer switch rating. Maximum current density permissible for Aluminium bus bars shall be 0.8 Amps/ 1 Sq.mm of bar without considering derating factors. An earthing busbar size shall be suitable for withstanding the fault current (6 MVA, 8 kA) and minimum 150 sq.mm section copper shall be provided outside panel at bottom throughout the length of the panel. All connections to individual circuits from the bus bar shall preferably be solid connections. The busbars shall be provided with heat shrinkable PVC insulating sleeve. Supports for busbars shall be made of suitable size cast resin ribbed insulators or SMC/DMC solid block type base and these should be adequate in number so as to avoid any sag in the busbars. (Hylam supports may not be used). Minimum clearance between phase to phase shall be as per IS/IEC standards. The entire panel shall have a common earth bar of size as specified with two terminals for earth connections.

F. Power Connection

For incoming and outgoing feeders of the switch boards, Aluminium conductor cable will be used and hence the panel has to be designed for receiving these and wherever required cable boxes shall be provided in panel by removable gland plates and shall be provided on top/bottom of panel, for cable entries. Adequate cable termination facility shall be made in the panel boards to terminate required runs and size of cables. To prevent accidental contacts, all interconnecting cables/ busbars and all terminals also shall be shrouded. Provision for clamping the cables inside the cable alley should be provided. Standard colour code of red, yellow and blue for phases and black for Neutral to be followed for all busbars/conductors.

G. Auxiliary wiring and Terminals

Wiring for all controls, protection, metering, signalling, etc. inside the switchboard shall be done with 650 volts grey colour minimum 1.5sqmm HFFR (Halogen free fire retardant) copper conductor cables except CT wiring. The CT wiring shall be done with minimum 2.5 sq mm wires with colour code. Control wiring to components fixed on doors shall be flexible type.

Wiring shall be suitably protected within switch board. Runs of wires shall be neatly bunched, suitably supported and clamped. All control wiring meant for external connections are to be brought out of terminal board. All control wiring should be provided with necessary cable sockets/ lugs at both ends. Conductors shall be terminated using compression type lugs. Each termination shall be identified at both the ends by PVC ferrules.

H. Component of switch boards

The panel shall be provided with 1 number of 125A MCCB, 2 Nos of 50A MPCBs, 4 numbers of 125/5A 0.5s class, CTs, 2 sets of star delta starter, instrument meters, Fabricated metal stand of dimension 500 X700 mm (HXW), etc. complete. The switch gears should be positioned inside the panel board as per manufacturers standards. For the star delta starter, three Nos. TP contactors suitable for AC-3 duty, bimetallic or other type of single-phase preventing type overload protection relay/inbuilt overload protection relay on MPCB in each type of starter and electronic timer in star delta starter. Bimetallic overload relays shall be with 3 elements, positive acting, ambient temperature compensated, time lagged, single phase preventing, hand reset type with adjustable settings. Unless specified otherwise elsewhere, each starter shall have start, stop, and reset, push buttons, On/OFF trip indicating lamps. Ammeter with ammeter selector switch to read motor line current shall be provided wherever specified, control circuit wired up to terminal for remote operation and power terminals to connect motor cables shall be provided.

I. Capacitors

Standard: IS 13340, IEC 60831

Rated voltage: 415V 50Hz

Type: APP Heavy duty Maximum Loss in watts: < 0.2 W/kVAr

Permissible over voltage: 10%

Capacitor should be of heavy duty all poly propylene type. All capacitors shall be of loss less than 0.5 W / kVAr, suitable to withstand + 10% voltage variation and rated for operating temperature up to 700C. Capacitor units shall be provided of rating specified in SOQ with externally mounted discharge resistors to reduce the residual voltage to less than 50 volts in one minute of switching off. Each capacitor unit shall be capable of operating continuously at 10% over voltage over and above the rated RMS voltage. The capacitor used shall be able to deliver kVAr mentioned in SOQ with 7% detuned reactors and 415V rated voltage.

J. Contactors

Contactors shall comply with IS 13947 and IS/IEC 60947 for general rules and standards pertaining to contactors and motor starters. The contactor shall be capable of withstanding breaking & making capacities per following: for capacitor switching should be of capacitor duty type (AC6B) with provision for reducing inrush current through a resistor, which closes prior to closing of the main contact.

K. Push Buttons

- 1 Type: Manually operated spring return type.
- 2 Standard applicable: IEC947-5-1
- 3 Electric Shock protection: Class 2 (IEC 536)
- 4 Degrees of protection: IP65
- 5 Diameter: 22mm
- 6 Type of mounting: snap type
- 7 Colour of actuator: Start PB - Green Stop PB - Red Test/Reset PB - Black
- 8 Contact configuration: 2NO+2NC.

L. Earthing

Two independent earthing points shall be provided outside the panel near bottom and these shall be inter-connected with Cu earthing busbars of minimum size 50 x 6 mm. All earthing points inside the distribution board shall be interconnected to these earthing points with copper conductor suitable for withstanding the fault current of 8 kA.

M. Name plates

Switch board/distribution board shall be provided with danger plate and name plates for all incoming and outgoing feeders. These name plates shall be of PVC (blue colour base & white letters engraved) screwed to panel. The size of each letters shall be 15mm x 10mm for Panel Board Identification name and remaining details shall be appropriate size and it shall be clearly visible from 1.5 meter away from the panel. PVC identification ferrule numbers shall be used for all internal wiring. The name plate shall contain the following information.

- ❖ Panel Board Identification name & number
- ❖ Feeder name.
- ❖ Switch/ fuse rating.
- ❖ Cable size.
- ❖ Feeder Cable from / To.....
- ❖ CT Ratio

N. Supports

Busbars shall be rigidly fixed to the supports, of SMC/DMC solid block type base. Busbars shall be firmly held within the slots in sheet type supports, which in turn shall be rigidly fixed to the chamber.

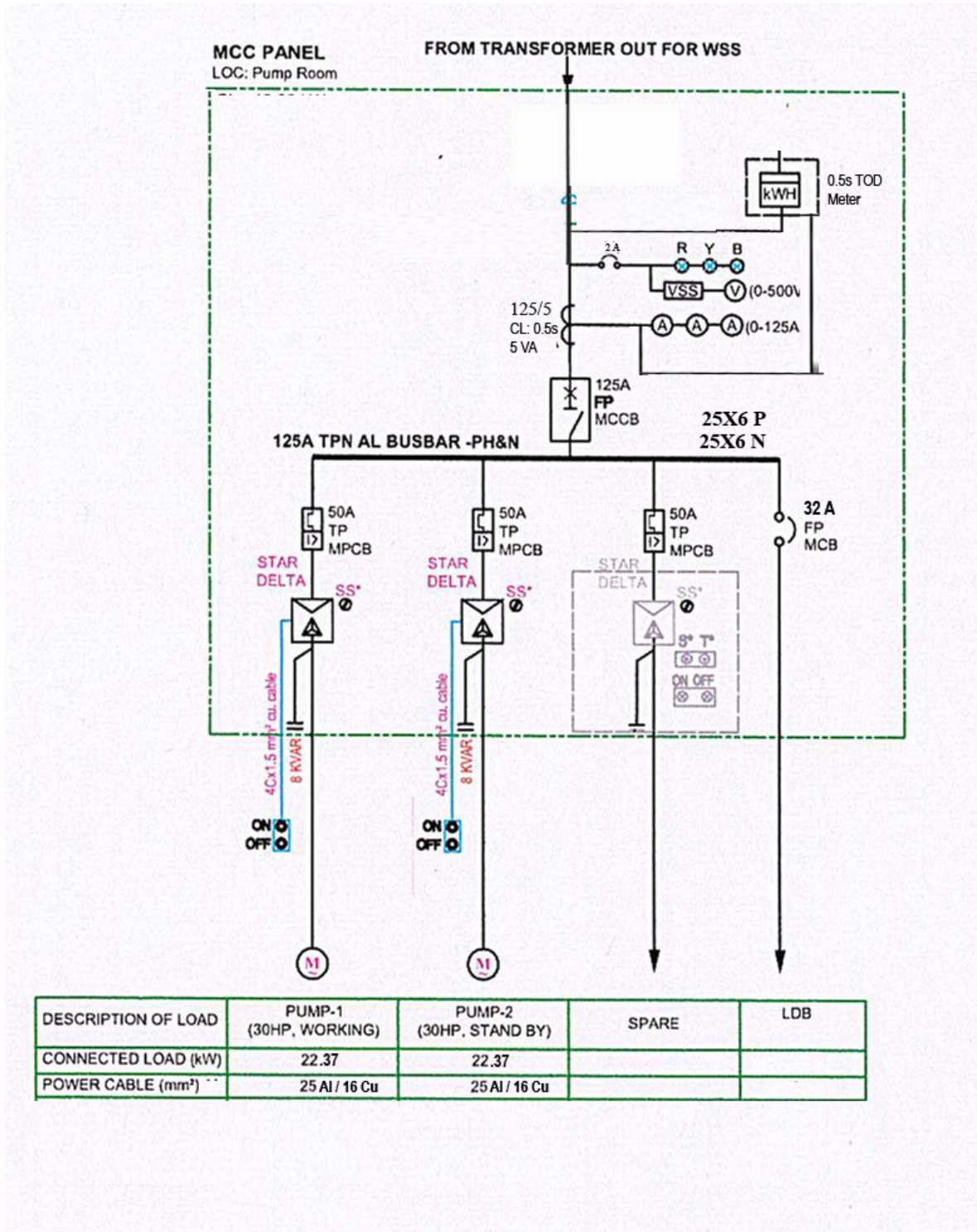
O. Factory Acceptance Tests and Routine tests:

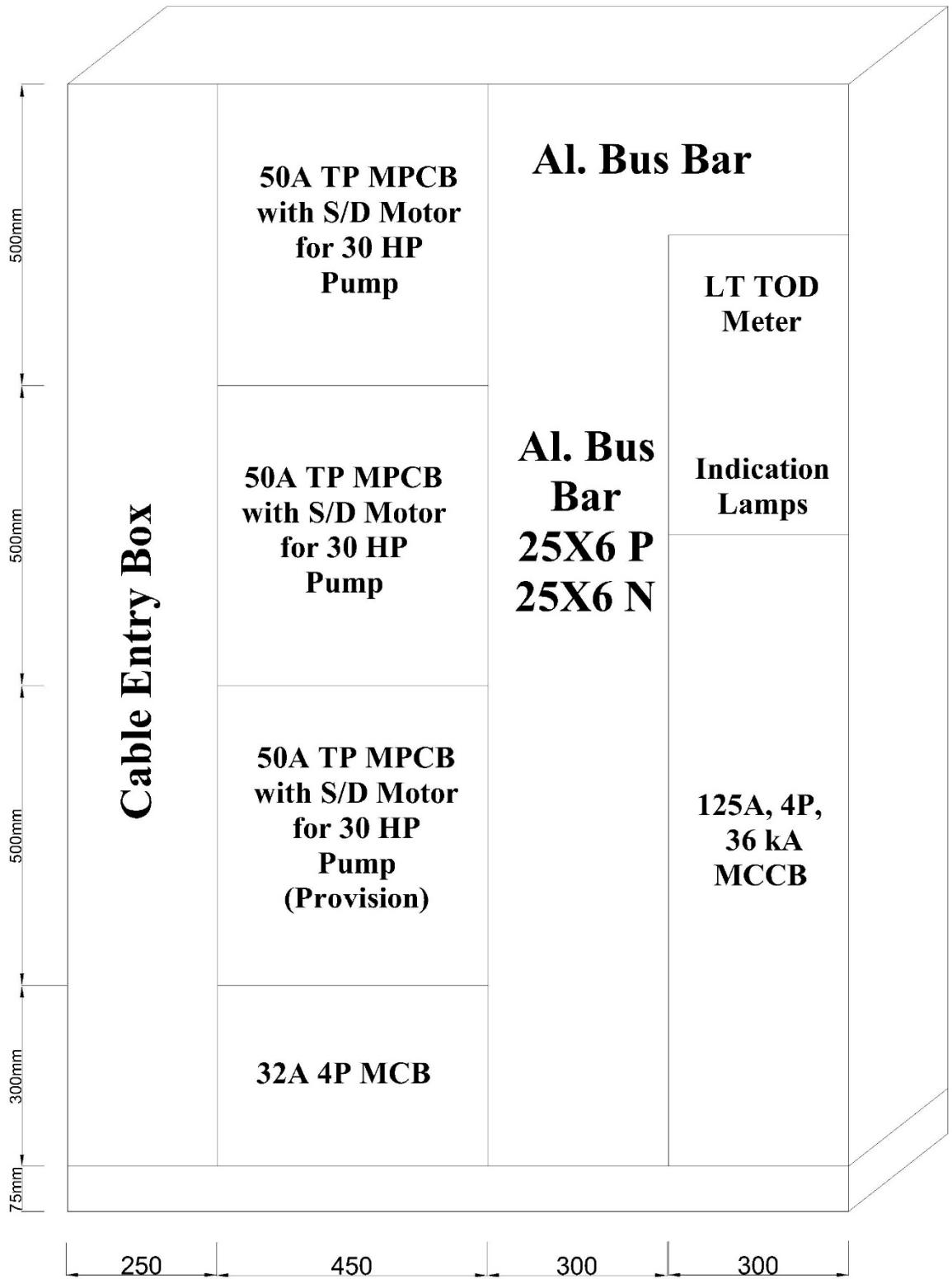
The bidder shall submit type test certificates for similar panels, demonstrating compliance with short circuit rating, temperature rise, and IP classification requirements. The contractor must obtain prior approval of all drawings from the client before commencing fabrication works. All routine tests, as per relevant IS/IEC standards, shall be conducted on the panels. The client reserves the right to inspect the progress of work, assess the quality of materials used and workmanship, and witness the routine tests upon completion at the manufacturer’s premises. The contractor shall secure dispatch clearance from the client after the successful completion of routine tests. The contractor shall give at least 07 days advance information to RPIPL about the manufacturing and Routine tests plan.
