A. RPIPL intends to engage an agency to carry out the Electrical Fire Audit in the 110/11 kV EHT Substation and 11 kV/433 V Unitized Substations. The objective of this assignment is to carry out the Electrical Fire Audit in compliance with the applicable regulation such as CEA (Measures relating to Safety and Electric Supply) Regulations 2023, CEA (Technical Standards for Construction of Electrical Plants and Electric Lines) Regulations, 2022, National Building Code of India 2016, IS 1646: 2017 - Code of Practice for Fire Safety of Electrical Installations, BIS-National Electrical Code of India 2023 etc.

7. TIME OF COMPLETION OF WORK

- A. The time of completion of the work will be 20 (Twenty) days from the date of work order. If there is any delay in completion of the work, penalty @ 1% on the contract value per week subject to a maximum of 10% will be recovered from the Contractor.
