1. Eligibility Criteria:

- a. The Bidder should be the original equipment manufacturer of the air conditioners of Approved Makes or an authorized dealer/agent/distributor/channel partner of the OEM. The bidder other than OEM shall submit proof of authorized dealer/agent/distributor/channel partner.
- b. The Bidder shall have valid GST registration.
- 2. The time for carrying out the supply, installation, testing and commissioning of the item shall be 15 days from the date of issue of purchase/work order. The items shall be delivered at the Office of Rubber Park India (P) Ltd. located at Irpauram Village in Kunnathunadu Taluk of Ernakulam District in Kerala State.

- 7. Earnest Money Deposit (EMD) of the unsuccessful bidders will be refunded without any interest on finalization of the contract with the successful bidder or on the expiry of the firmperiod of tender plus 60 days whichever is earlier.
 - EMD deposited with the client will be forfeited / encashed under the following circumstances.
- If the bidder withdraws his bid during the firm period specified.
- If the successful bidder fails within the time limit to sign the contract agreementor fails to furnish the required performance security deposit.
- 8. The bid submitted is treated as invalid if the bidder does not submit all the documents (as stipulated in the bid document).
- 9. The competent authority on behalf of Managing Director, Rubber Park India (P) Ltd. does not bind itselfto accept the lowest or any other bid and reserves

- to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in whichany of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.
- 10. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable for rejection.
- 11. The competent authority on behalf of Managing Director, Rubber Park India (P) Ltd. reserves to himselfthe right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.
- 12. The contractor shall not be permitted to bid for supply if he/she is the near relative of an officer of Rubber Park India (P) Ltd.
- 13. The bid for the supply shall remain open for acceptance for a period of 60 days from the date of opening of bids. If any bidder withdraws his bid before the said period or issue of Purchase order, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to Rubber Park India (P) Ltd., then Rubber Park India (P) Ltd. shall, without prejudice to any other right or remedy, be at liberty to forfeit 100% ofthe said earnest money as aforesaid. Further the bidders shall not be allowed to participate in the rebidding process of the Purchase and will be blacklisted.
- 14. The intending bidders shall ensure that the equipment offered are fully met with the guaranteed technical specifications mentioned in the tender and submit the technical specification compliance undertaking as per Annexure-1 along with the bid.
- 15. The intending bidders have to quote their corresponding item rates in schedule of quantities along with the price bid. The quoted price will be considered as all-inclusive rate inclusive of cost of all materials, labour charges, transportation, packing, freight and insurance charges, all overheads, contingencies, profits, taxes (ie., Income tax etc.), duties/levies, cost of scaffoldings, tools for installation and commissioning, loading and unloading charges etc., complete for the supply, installation, testing and commissioning of the Air Conditioners at Rubber Park India (P) Ltd, located at Irapuram, Ernakulam but only exclusive of GST. The rates quoted by the Contractor shall be firm throughout the contract period and there shall be no upward revision of the rates quoted by the Contractor for any

- reasons whatsoever. The price bid shall be evaluated based on the Total Price excluding GST for all the items and deduction for buy back of existing Ductable AC, worked out after considering discrepancies, if any.
- 16. The successful bidder on receipt of the Work Order, shall deposit an amount equal to 5 % (Five percent) of the contract value, as Performance Guarantee in the form of of DD in favor of the Managing Director, Rubber Park India (P) Ltd. payable at Valayanchirangara or online transfer to the account (Account No. 00000038377727468, Name of Account holder: Rubber Park India (P) Ltd., Bank & Branch: State Bank of India, Valayanchirangara., IFSC Code: SBIN0070558) within 7 days from the date of Work Order and the Performance Guarantee will be retained till 90 days after the expiry of the AMC Period. On completion of AMC period, the Engineer-in-Charge of Rubber Park shall recommend on demand from the bidder/Contractor to refund to him the Performance Guarantee and the same will be refunded/ released by the Accepting Authority provided that the Engineer-in- Charge is satisfied that there is no defect/liability outstanding against the bidder/contractor. All the deposits of EMD, performance guarantee will not bear any interest whatsoever.
- 17. The bidder shall Warranty for all items supplied against any defect arising out of faulty design or workmanship or defective material for a period of 01 Year from the date of supply, installation, testing and commissioning of item at the site. The bidder shall submit the warranty certificate along with the equipment in favour of the Managing Director Rubber Park India (P) Ltd.
- 18. This notice inviting Tender shall form a part of the contract document. The successful bidders / contractor, on acceptance of his bid by the Accepting Authority shall within 7 days from the date of purchase order/letter of award, sign the contract consisting of the notice Inviting Bid, all the documents including additional conditions and specifications, if any, form part of the bid and the rates quoted at the time of submission of bid and acceptance thereof together with any correspondence leading thereto.
- 19. If the successful bidder fails to complete the supply, installation, testing and commissioning in time specified, he shall, without prejudice to any other right or remedy available under the law to the Government on account of such breach, pay as agreed compensation the amount calculated at the rates 1% per week or part of the week on the total contract value of the order subject to a maximum of 10% of the contract value. The successful bidder shall not be liable for delays in performing his obligations resulting from any force majeure cause as referred to and/or defined below. If the successful bidder fails to rectify the air conditioners within 24 hours from

reporting of complaint during the AMC Period, a Penalty at the rate of Rs. 1000/- (Rupees Thousand only) per incident will be recovered from the quarterly bills of AMC. Force majeure is herein defined as any cause which is beyond the control of the Contractor or the Owner as the case may be, which they could not foresee or with a reasonable amount of diligence could not have foreseen and which substantially affects the performance of the Contract, such as:

- a. Natural phenomena, including but not limited to floods, droughts, earthquakes and epidemics;
- b. Acts of any Government, domestic or foreign, including but not limited to war, declared or undeclared, priorities, guarantees, embargoes.

Then upon the happening of any such event causing delay, the contractor shall within 07 days give notice thereof in writing to the authority, but shall nevertheless use constantly his best endeavors to prevent or make good the delay and shall do all that may be reasonably required to the satisfaction of Rubber Park India (P) Ltd, to proceed with the supply.

20. Payment Terms for Supply & Installation

The Payment for the supply, installation, testing and commissioning shall be released within 10 days after successful commissioning of the total item as per the schedule of quantities against the submission of GST invoice and reflection of payment towards the buyback of materials. The payment for AMC shall be on quarterly basis on rendering satisfactory service and the payment will be released within 10 days from the date of submission of GST invoice. The quarterly bills must be enclosed with the service reports. The GST portion of the invoice would be released only after reflection of GST amount in our GSTR 2B. TDS as per rules shall be deducted from the bills.

21. Scope of Work: -

A. Supply and Dismantling works: -

- 1. Dismantle the existing 2 numbers of 5.5 Tr Ductable Split Air Conditioning Unit (Make: Carrier) from Rubber Park India (P) Ltd, Irapuram in 'as is where is basis' condition.
- 2. Supply, installation, Testing & Commissioning of 5.5 TR Ductable Inverter split AC unit with energy efficient scroll compressor & code remote controller, outdoor unit stand, modification of ducting mouth, refrigent pipe, interconnecting control cable etc., inclusive of cost of all materials, labour charges, transportation, packing, freight and insurance charges, all overheads, contingencies, profits, taxes (i.e., Income tax etc.), duties/ levies, cost of scaffoldings, tools for installation and

commissioning, loading and unloading charges etc., complete.

B. All-inclusive Comprehensive Annual Maintenance Contract (CAMC): -

- The All-inclusive Comprehensive Annual Maintenance Contract (CAMC) is for a period of four years from the expiry of the defect liability/warranty period.
- 2. This all-inclusive comprehensive Contract includes replacement of all faulty spares like Compressors, condenser coils (Only copper), Starting Capacitors, Running Capacitors, Relays, Thermostats, Fan Capacitors, Fan Motors, Selector switches, Power Contactors, Control Contactors, External Time Switch Units provided for specific time running of A.C's, Rewinding of motors, providing Ball bearing of motors, Fan blades, Electronic Control Circuitry, Remote Control units, etc. at Contractor's cost including the cost for attending all complaints and breakdowns, conveyance, Gas charging, cost of labour, scaffoldings and tools.
- 3. Only original spare parts of the OEM will be permitted to be used for the maintenance during the AMC Period.
- 4. Periodical preventive servicing has to be carried out once in three months for all the Air conditioners covered under AMC. During the quarterly servicing, the contractor should water service the AC unit including water washing of filter, drain tray and pipe cleaning, Evaporator brush cleaning, oiling/greasing of all Fans, checking of current consumption, checking of output performance, testing of Gas pressure and refilling the gas if necessary as per the OEM standards, water washing of Condenser Coil rectification of minor leaks, attending to faults, checking & observing performance of the units, their safety controls & cutouts cleaning of condenser coil, checking the refrigeration system, & accessories, Overhauling of blower motor, Carrying out decaling of condenser coil once in a year and Carrying out chemical cleaning of evaporator coils once in a year.
- 5. The scope of the contract will include ANY NUMBER of breakdown calls. The Complaints regarding the non-functioning of air-conditioners are to be attended within 24 hours from the time of reporting the complaint. In case of Minor technical problems same are to be rectified within same day of diagnosing of complaint. In case of major technical problems, the same are to be rectified within 48 hours of reporting the complaint. The AMC Contractor is entitled to take back the old faulty/damaged parts of the Air-conditioner, which are replaced by new parts.

- 1. - 2. The "RPIPL" shall pay the Contractor, the Contract Amount or such other sum that may become payable at times and in the manner hereinafter specified in the said conditions.
- 3. The said conditions thereto shall be read and constructed as forming part of this agreement and the parties hereto shall respectively abide by and submit themselves to the said conditions and perform the agreement on their part respectively in the said conditions.
