## 2. Scope of Work:

The work includes **refurbishing the faulty Demattia Flexion Testing Machine (Make: Gibitre Instruments)** and restoring it to full operational condition. The scope shall cover, but not be limited to, the following:

- A. Inspection and removal of the existing faulty components, including the defective Variable Frequency Drive (VFD) and any associated control elements identified as non-functional.
- B. Supply, installation, and integration of a new compatible Variable Frequency Drive (VFD), of the approved make, suitable for the machine's operational requirements.
- C. Replacement of associated control system components, of the approved make, including but not limited to:
  - i. a). Programmable Logic Controller (PLC) and Separate Human Machine Interface (HMI)  
OR  
b). Programmable Logic Controller (PLC) with integrated Human Machine Interface (HMI)
  - ii. Switch Mode Power Supply (SMPS)
  - iii. Any other components required for seamless operation.
- D. Development, modification, or reconfiguration of required software/programming for the PLC and HMI or PLC-HMI UNIT to ensure proper functionality of the machine.
- E. Execution of all necessary control wiring, terminations, and panel integration to interface the newly installed components with the machine.
- F. Calibration, testing, and trial run of the machine to ensure performance meets the intended operational parameters.
- G. Final commissioning of the Demattia Flexion Testing Machine in fully operational condition.
- H. Submission of documentation, including component specifications, wiring diagrams, programming backups, and commissioning reports.
- I. Each bidder shall visit and inspect the faulty machine to thoroughly understand the issues and familiarize themselves with the machine condition, as well as the scope, quantities, and nature of the work, before submitting their quotation.
- J. No claims for additional charges shall be entertained on account of any oversight, misunderstanding, or lack of proper site assessment by the bidder
- K. All work shall be carried out **as per the directions of the Engineer-in-Charge**, using best engineering practices and ensuring compliance with relevant safety and quality standards.





### 3. PRICES

- A. The Rate quoted shall be inclusive of all taxes and duties inclusive of transportation, insurance charges, all overheads, contingencies, profits, taxes (ie. Income tax etc.), duties/ levies, etc., for refurbishing the faulty **De Mattia Flexon Check Testing Machine** (make: Gibitre Instruments) at JJMRC, Rubber Park, Irapuram, Ernakulam Dist., as per the technical specifications, except **GST**.
- B. The *prices should be stated in figures as well as in words*. In case of any discrepancy between the two, the amount written in words will be taken as correct.
- C. The rate quoted shall be firm throughout the period of contract. Price variation cannot be accepted.

### 4. VALIDITY

- A. The bid for the works shall remain open for acceptance for a period of thirty (30) days from the date of opening of the Quotation.

### 7. WARRANTY

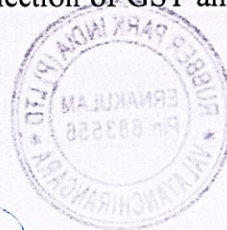
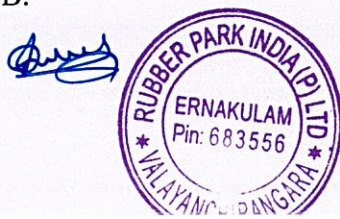
- A. The bidder should give warranty of 01 Year comprehensive warranty for the work and for the materials from the date of supply, Installation and Commissioning. The bidder shall submit the warranty certificate along with the equipment in favour of the Managing Director – Rubber Park India (P) Ltd.

### 8. TIME OF COMPLETION OF SUPPLY

- B. The time of completion of the supply at the site of Rubber Park India (P) Ltd at Irapuram will be 20 (Twenty) days from the date of work order. If there is any delay in supply, penalty @ 1% on the contract value per week subject to a maximum of 10% will be recovered from the Contractor.

### 09. TERMS OF PAYMENT

- A. The Payment for the supply, installation and commissioning shall be released on successful commissioning of the equipment within 10 days against the submission of GST invoice and satisfactory completion of the works as well submission warranty certificate. The GST portion of the invoice would be released only after reflection of GST amount in our GSTR 2B.
