The bidder shall submit duly signed and stamped complete Quotation forms/documents along with the Price Bid. The Rubber Park shall not be responsible for the delay or non-receipt of the Sealed Quotations sent by post or courier.

The bidders are requested to read the documents (Specifications, Terms & conditions etc.) carefully and ensure compliance with all specifications/instructions herein. Non-compliance with specifications/instructions in this document will disqualify the bidders. The undersigned reserves the right to reject any bids wholly or partly without assigning any reason. Incomplete bids, amendments and additions to bids after opening or late submission of the bids are liable to be ignored and rejected.

2. Eligibility Criteria:

The Bidders who fulfil the following requirement shall be eligible to apply.

- A. The Bidder shall have valid GST registration.
- B. The bidder shall have valid CPWD/KPWD Class D (or equivalent class) or above.
- C. The successful bidder shall, before commencement of the work, deploy a **qualified Supervisor holding a valid "All EHT Supervisor's Licence"** issued by the **Kerala State Electricity Licensing Board**. The work permit for execution of the work shall be issued only to such licensed Supervisor. A self-attested copy of the valid licence shall be submitted to Rubber Park India (P) Ltd. for verification and approval prior to commencement of the work.

3. PRICES

- A. The Rate quoted shall be inclusive of the cost of all materials and consumables, labour, hire charges for all machinery, scaffolding, transportation, insurance charges, all overheads, contingencies, profits, taxes (ie. Income tax etc.), duties/levies, loading and unloading charges etc. complete, excluding **GST**.
- B. The *prices should be stated in figures as well as in words*. In case of any discrepancy between the two, the amount written in words will be taken as correct.
- C. The rate quoted shall be firm throughout the period of contract. Price variation cannot be accepted.

4. VALIDITY

- A. The bid for the works shall remain open for acceptance for a period of thirty (30) days from the date of opening of the Quotation.

5. RIGHT OF ACCEPTANCE

- A. Rubber Park reserves the right of rejecting any or all the bids wholly or partially without assigning any reasons whatsoever.

6. DOCUMENTS TO BE SUBMITTED

- A. Signed Quotation notice.
- B. Copy of GST Registration, if applicable.
- C. Signed Forms and Price Bid.

7. Defect liability period

- A. The successful bidder shall give guarantee for 06 months for the works carried out from the date of completion of the repainting. Any defects observed during the defect liability period due to poor workmanship are to be rectified or replaced by the contractor at their own expense.

8. TIME OF COMPLETION OF WORK, AGREEMENT & PERFORMANCE GUARANTEE

The time of completion of the work will be 30 days from the date of work order. The contractor shall execute an Agreement for the work in non-judicial stamp paper worth Rs. 200 within 7 (seven) days from the date of Work Order (WO). Failing which the WO will be cancelled and the bidder will be black listed. If there is any delay in completion of the work, penalty @ 1% on the contract value per week subject to a maximum of 10% will be recovered from the Contractor. The successful bidder on receipt of the Work Order, shall deposit an amount equal to 5 % (Five percent) of the contract value, as Performance Guarantee in the form of DD in favor of the Managing Director, Rubber Park India (P) Ltd. payable at Valayanchirangara or online transfer to the account (Account No. 00000038377727468, Name of Account holder: Rubber Park India (P) Ltd., Bank & Branch: State Bank of India, Valayanchirangara., IFSC Code: SBIN0070558) within 7 days from the date of Work Order. All the deposits of EMD, performance guarantee will not bear any interest whatsoever. The validity of Performance guarantee shall be up to 2 months after defects liability period. On completion of Defects Liability Period, the Engineer-in- Charge shall recommend on demand from the Contractor to refund to him the Performance Guarantee and the same will be refunded/ released provided that the Engineer-in-Charge. is satisfied that there is no demand outstanding against the contractor. If the contractor is failed to carryout rectification works during defect liability period (DLP), PG will be forfeited, and company/contractor will be blacklisted without further notice.

9. TERMS OF PAYMENT

- A. Payment would be made within 10 days after successful completion of the work against the submission, verification and acceptance of the GST invoice.
- B. *No mobilization advance* will be applicable.
- C. **The GST portion of the invoice would be released only after reflection of GST amount in the GSTR 2B of Rubber Park.**

10. OTHER TERMS AND CONDITIONS

- A. All the necessary precautions are to be taken by the successful bidder for the safety of employees engaged by them for the work as per the CEA (Measures relating to safety and Electric supply) Regulations, 2023 & its amendments thereof. RPIPL

shall not be liable for, in respect of any damages or compensation payable as per regulations or in consequence of any accident or injury to any workmen or other person in the employment of the Bidder or his sub-contractors, and the Bidder shall indemnify and keep indemnified RPIPL against all such damages and compensation and against all claims, demands, proceedings, costs, charges and expenses whatsoever in respect thereof or in relation thereto. The successful bidder shall be responsible for the safety of all employees and or workers employed or engaged by him on and in connection with the works.

- B. The successful bidder shall ensure that only qualified, trained, experienced & conversant persons are to be engaged / employed for execution of the work awarded to them.
- C. The successful bidder shall take all the required safety measures prior to commencement of work on dangerous substances, machineries or area at which cautionary notice is displayed and obtain “Line Clear” or “Work Permit” through the concerned Department / Section. Prior to welding, cutting, heating or any other hot work job, remove all the inflammable material lying at or nearby worksite or cover it properly by suitable protective covering.
- D. Prior to make use of any power / electrically operated hand tools/equipment/machines like welding/cutting machine/hand grinder/hand drill etc., ensure for its safe operation & use it only if it is found safe to use. Do not use defective, unsafe or improperly maintained equipment.
- E. It is compulsory to use standard make Personal Protective Equipment (P.P.Es.) such as Helmets, safety belts, safety shoes etc., while at work as per the job requirement. If your staff is found working without P.P.Es., the ongoing work will be stopped at your risk & cost. It is compulsory to use helmet with fastened chinstrap and safety belt with anchored rope while climbing on scaffolding or working on any structure at height.
- F. On completion of the work, cotton waste, spilled oil / grease, pieces of welding rod and other waste material shall be removed from work site and the area shall be left safe, neat and clean.
- G. No construction equipment shall be supplied by RPIPL unless, otherwise specified. The contractor shall arrange/ensure the deployment of suitable cranes/required equipment and take all safety precautions during execution of work.
- H. Over and above these, contractor shall have to observe, follow & comply with all safety related requirements/rules and regulations/norms and legal provisions laid down in various statutes. The contractor shall also obey the rules / regulations / instructions of the local Competent Authority/RPIPL for safety requirements.
