The following Corrigendum/Addendum/Clarification in response to queries raised by prospective bidders shall form an integral part of bid document and it may amount to an amendment of relevant Para/clause of the bid document.

02	Section 1, Clause 1.09	Performance Guarantee and Security Deposit: ** Please specify the acceptable forms of payment for the Performance Guarantee. Additionally, we would like to confirm if the full amount of the Security Deposit can be furnished via a Bank Guarantee.	As per the Tender Terms and Conditions
03	Section 6, Clause 6.2	Include D-link & Finolex CAT-6 UTP Cable in the List of Approved Makes.	<i>D-Link</i> and <i>Finolex</i> have been included in the List of Approved Makes for CAT-6 UTP Cables, in addition to the existing makes — <i>Honeywell</i> , 3C3, <i>Panduit</i> , <i>Simon</i> , and <i>Systimax</i>
04	Section 5, Clause 5.4	Backbone cabling: - Please specify the LAN cabling network used for control room connectivity.	Not required.
05	Section 6	STQC certification is generally applicable to IP Cameras and not to NVRs . Most OEMs do not have STQC-certified NVR models. Kindly confirm whether non-STQC NVRs shall be acceptable.	STQC certification for CCTV cameras is mandatory. However, STQC certification for the Network Video Recorder (NVR) is exempted. The CCTV cameras to be supplied shall be of uniform make across all locations, and the NVR shall be of the same make as the cameras to ensure system compatibility and seamless integration.

06	Section 6	As most OEMs manufacture outdoor racks starting from a minimum size of 6U , please confirm if a 6U outdoor rack can be proposed in place of the 4U rack specified in the BOQ.	The rack specified in the tender document represents the minimum requirement. The bidder has the option to supply a higher capacity rack.
07	Section 6	The performance of the 5G dual-band router will depend entirely on the SIM network speed available at the site. Camera clarity and video resolution are also dependent on the same network bandwidth. Additionally, there is a possibility of camera downtime due to the dependency on solar power , especially during unfavorable weather conditions. We request leniency on these performance parameters considering the external dependencies.	As per Tender Terms and Conditions
08	Section 6	Kindly confirm whether the 150W solar panel with 100Ah battery specification must be followed strictly, or if an equivalent nearby configuration can be considered acceptable.	Higher capacity shall be acceptable; however, the minimum requirement shall be a 150W solar panel with a 100Ah battery. The design approval shall be obtained from the client during detailed engineering by the Contractor.
09	Section 6	For 25mm PVC conduit with wall chasing , please clarify if the entire quantity includes both conduit laying and wall chasing works.	As per Tender Terms and Conditions
10	Section 6	Please confirm whether GI pipe laying is to be carried out through excavation up to 0.6 meters depth for the entire mentioned quantity, across all areas.	As per Tender Terms and Conditions

11	Section 6	The tender currently specifies Cat 6 UTP cable. However, during the pre-bid meeting, the tender authority verbally confirmed that a fully outdoor-rated Cat 6 cable is required. We respectfully request that the requirement for a fully outdoor-rated Cat 6 cable be explicitly documented in the official corrigendum.	It is clarified that outdoor-rated Cat 6 cable shall be provided for all locations, including both indoor and outdoor areas.
12	Section 6	SIM-Based Router Performance: If a SIM-based router is utilized, signal buffering or quality fluctuation may occur due to external network conditions. This will affect the overall performance of the system. Ownership of the performance will rest with the end user. Hence Air fiber solution may be opted.	As per Tender Terms and Conditions
13	Section 6	Solar Panel Performance in Low Light/Rain: During periods of heavy rain or low sunlight, the solar panels may not charge sufficiently. Please clarify whether the customer will assume responsibility for ensuring system operation or managing performance issues that arise specifically during these low-light/rainy conditions.	As per Tender Terms and Conditions
14	Section 6	Power Supply Requirement: ** Is an Uninterrupted Power Supply (UPS) required at all installation locations? Please clarify this requirement.	The Provision for power supply from the UPS shall be made available for the installation. However, the supply and installation of the UPS shall not be under the scope of the bidder.
