2.0 PRICES

- A. The Rate quoted shall be inclusive of all taxes and duties inclusive of conveyance charges, insurance, etc., complete for the supply of the materials at the Pump House of KWA, Kunnathunadu Taluk, Ernakulam Dist., except GST.

3.0 VALIDITY

4.0 RIGHT OF ACCEPTANCE

A. Rubber Park reserves the right of rejecting any or all the bids wholly or partially without assigning any reasons whatsoever.

5.0 TIME OF COMPLETION OF SUPPLY

- A. The time of completion of the supply will be 15 (Fifteen) days from the date of purchase order.
- B. If there is any delay in supply, penalty @ 1% on the contract value per week subject to a maximum of 10% will be recovered from the Contractor.
- C. The successful Bidder shall execute an agreement in Kerala stamp paper worth Rs.200/- with the Managing Director, Rubber Park India (P) Ltd within 7 (Seven) days from the date of Purchase Order.

6.0 TERMS OF PAYMENT

- A. Payment would be made within 10 days after successful completion of the supply against the submission, verification and acceptance of the bill by Rubber Park India (P) Ltd., Irapuram, Ernakulam Dist. GST portion of the invoice would be released only after reflection of GST amount in our GSTR 2B.
- B. **No mobilization advance** will be applicable for the supply.

7.0 OTHER TERMS AND CONDITIONS

- A. Supply and delivery of Open Well submersible pump set for Pump House of KWA at Kunnathunadu Taluk, Ernakulam District., shall be free of charge. Any damage of the equipment during transit will be on account of the contractor. Defective equipment's will be rejected and the same shall be replace at their cost.
- B. The intending bidders shall ensure that the equipment offered shall be fully met with the technical specifications mentioned with the quotation notice as Annexure-1.
- C. One-year unconditional warranty shall be provided for the Water Pump. Warranty period will commence from the date of supply. The warranty certificate shall be submitted by the Bidder along with the supply of the equipment in favour of the Managing Director Rubber Park India (P) Ltd.
- D. During the warranty period, complaint shall be reported by the **Kerala Water Authority or LSGD or Rubber Park India (P) Ltd** and the Contractor shall rectify the same immediately.
- E. Invoice (in duplicate) shall be submitted to the Managing Director, Rubber Park India (P) Ltd for releasing payment. Payment will be released only after verification and acceptance of equipment.
- F. The verification and certification of the equipment's will be done by **Kerala Water Authority or LSGD or Rubber Park India (P) Ltd** for which necessary support shall be provided by the contractor.
- G. The successful bidder should provide warranty for 12 months from the date of supply of the material at site. The bidder should submit the warranty certificate along with the equipment in favour of the Managing Director Rubber Park India (P) Ltd.

8.0 SECURITY DEPOSIT (S.D): -

- 1.
