6. Earnest Money Deposit (EMD) of the unsuccessful bidders will be refunded without any interest on finalization of the contract with the successful bidder or on the expiry of the firm period of tender plus 30 days whichever is earlier.  
  
EMD deposited with the client will be forfeited / encashed under the following circumstances.
  - If the bidder withdraws his bid during the firm period specified.
  - If the successful bidder fails within the time limit to sign the contract agreement or fails to furnish the required performance security deposit.
8. The bid submitted is treated as invalid if the bidder does not submit all the documents (as stipulated in the bid document).
9. The Managing Director, Rubber Park India (P) Ltd. does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.
10. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable for rejection.
11. The Managing Director, Rubber Park India (P) Ltd. reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.
12. The contractor shall not be permitted to bid for supply if he/she is the near relative of an officer of Rubber Park India (P) Ltd.
13. The bid for the supply shall remain open for acceptance for a period of 30 days from the date of opening of bids. If any bidder withdraws his bid before the said period or issue of Purchase order, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to Rubber Park India (P) Ltd., then Rubber Park India (P) Ltd. shall, without prejudice to any other right or remedy, be at liberty to forfeit 100% of the said earnest money as aforesaid. Further the bidders shall not be allowed to participate in the retender process of the Purchase and will be blacklisted.

14. The Bidders who have been debarred or blacklisted by the Central Government, State Governments, Public Sector Undertakings (Central or State), or any other local body are not eligible to participate in the tendering process. Any bids submitted by such disqualified bidders will be deemed invalid and will not be considered.
15. The intending bidders shall ensure that the equipment offered are fully met with the technical specifications mentioned in the tender and submit the technical specification compliance undertaking as per Annexure-1 along with the bid.
16. The intending bidders have to quote their corresponding item rates in schedule of quantities along with the price bid. The quoted price will be considered as all-inclusive rate inclusive of cost of transportation, packing, freight and insurance charges, all overheads, contingencies, profits, taxes (ie. Income tax etc.), duties/ levies, loading and unloading charges, installation charges etc., complete, for supply and installation of the equipment at **St. Paul's Govt. LPS, Irapuram, Ernakulam** but only exclusive of GST. The rates quoted by the Contractor shall be firm throughout the contract period and there shall be no upward revision of the rates quoted by the Contractor for any reasons whatsoever.
17. Any damage of the equipment during transit will be on account of the contractor. Defective equipment's will be rejected and the same shall be replace at their cost.
18. The successful bidder on receipt of the Purchase Order, shall deposit an amount equal to 5 % (Five percent) of the contract value, as Performance Guarantee in the form of DD in favor of **the Managing Director, Rubber Park India (P) Ltd. payable at Valayanchirangara** or online transfer to the account (**Account No. 00000057042660807, Name of Account holder: Rubber Park India (P) Ltd., Bank & Branch: State Bank of India, Valayanchirangara., IFSC Code: SBIN0070558**) within 7 days from the date of purchase order and the Performance Guarantee will be retained till 90 days after the expiry of the Warranty /Defect liability Period. On completion of Warranty/Defect liability Period, the Engineer-in-Charge of Rubber Park shall recommend on demand from the bidder/Contractor to refund to him the Performance Guarantee and the same will be refunded/ released by the Accepting Authority provided that the Engineer-in- Charge is satisfied that there is no defect/liability outstanding against the bidder/contractor. All the deposits of EMD, performance guarantee will not bear any interest whatsoever.

19. The bidder shall Warranty for all items supplied against any defect arising out of faulty design or workmanship or defective material for a period of one year from the date of supply and Installation of item at the site.
20. The bidder shall submit the warranty certificate along with the equipment in favour of the Managing Director - Rubber Park India (P) Ltd. During the warranty period, complaint shall be reported by the **St. Paul's Govt. LPS, Irapuram, Ernakulam** and the Contractor shall rectify the same immediately. If the defect is not rectified immediately, repairing cost will be recovered from the performance guarantee furnished by the Contractor without notice.
21. This notice inviting Tender shall form a part of the contract document. The successful bidders / contractor, on acceptance of his bid by the Accepting Authority shall within 7 days from the date of purchase order, sign the contract consisting of the notice Inviting Bid, all the documents including additional conditions and specifications, if any, form part of the bid and the rates quoted at the time of submission of bid and acceptance thereof together with any correspondence leading thereto.
22. If the successful bidder fails to complete the supply in time specified, he shall, without prejudice to any other right or remedy available under the law to the Government on account of such breach, pay as agreed compensation the amount calculated at the rates 1% per week or part of the week on the total contract value of the order subject to a maximum of 10% of the contract value. The successful bidder shall not be liable for delays in performing his obligations resulting from any force majeure cause as referred to and/or defined below.

Force majeure is herein defined as any cause which is beyond the control of the Contractor or the Owner as the case may be, which they could not foresee or with a reasonable amount of diligence could not have foreseen and which substantially affects the performance of the Contract, such as:

- a. Natural phenomena, including but not limited to floods, droughts, earthquakes and epidemics;
- b. Acts of any Government, domestic or foreign, including but not limited to war, declared or undeclared, priorities, guarantees, embargoes.

Then upon the happening of any such event causing delay, the contractor shall within 07 days give notice thereof in writing to the authority, but shall nevertheless use constantly his best endeavors to prevent or make good the delay and shall do all that may be reasonably required to the satisfaction of Rubber Park India (P) Ltd, to proceed with the supply.



## 23. Payment Terms for Supply & Installation

GST Invoice (in triplicate) shall be submitted to the Managing Director, Rubber Park India (P) Ltd for releasing payment. Payment will be released only after verification and acceptance of equipment by the **St. Paul's Govt. LPS, Irapuram**. The verification and certification of the equipment's will be done by **St. Paul's Govt. LPS, Irapuram.**, for which necessary support shall be provided by the contractor. Payment shall be released within 15 days after successful delivery of the total item as per the schedule of quantities along with warranty certificate and invoice. Date of delivery of the items in good condition at Rubber Park will be considered as date completion of supply. The GST portion of the invoice would be released only after reflection of GST amount in our GSTR 2B.

8. The Contractor shall indemnify and keep indemnified “RPIPL” against all losses and claims for injuries or damages to any person or property whatsoever which may raise out of or in connection with the supply/ work and against all claims, demands, proceedings, damages, cost, charges, expenses whatsoever in respect thereof in relation thereto.
9. It is specifically understood that the Contractor shall not be eligible for or entitled to claim any amount except to the extent allowed or due under the terms of this contract. It should be understood that on no account, the rates once agreed to and quoted in the tender, shall be revised.
10. It is specifically understood that supply/work should be completed in all respects within the stipulated time. Any delay in completing the project in time will attract compensation as per tender condition.

17. All disputes arising out of or in any way connected with this agreement shall be deemed to have arisen in Kerala and only courts in Perumbavoor shall have jurisdiction to determine the same.
