1. **Eligibility Criteria:**

Bidders who fulfil the following requirements shall be eligible to apply.

- The bidder shall be an Original Equipment Manufacturers (OEM)/ Authorized Indian dealers/agents/supplier of the Approved Make. The bidders other than the OEM shall submit the proof of such authorisation from the OEM along with the bid.
  - The Bidder should have valid GST registration
- The time for carrying out the supply of the item shall be 45 days from the date of issue of purchase order. The item shall be delivered at the Pump House of Rubber Park India (P) Ltd. located at Irapuram Village in Kunnathunadu Taluk of Ernakulam District in Kerala State.

5. The bid submitted will be opened on 30.01.2026 at 03.00 PM in the office of Rubber Park India (P) Ltd, 2A Kautileeyam, Valayanchirangara, Ernakulam 683 556.

6. Earnest Money Deposit (EMD) of the unsuccessful bidders will be refunded without any interest on finalization of the contract with the successful bidder or on the expiry of the firm period of tender plus 30 days whichever is earlier.

EMD deposited with the client will be forfeited / encased under the following circumstances.

- If the bidder withdraws his bid during the firm period specified.
- If the successful bidder fails within the time limit to sign the contract agreement or fails to furnish the required performance security deposit.

8. The bid submitted is treated as invalid if the bidder does not submit all the documents (as stipulated in the bid document).

9. The competent authority on behalf of Managing Director, Rubber Park India (P) Ltd. does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.

10. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable for rejection.

11. The competent authority on behalf of Managing Director, Rubber Park India (P) Ltd. reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.

12. The contractor shall not be permitted to bid for supply if he/she is the near relative of an officer of Rubber Park India (P) Ltd.

13. The bid for the supply shall remain open for acceptance for a period of 30 days from the date of opening of bids. If any bidder withdraws his bid before the said period or issue of Purchase order, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to Rubber Park India (P) Ltd., then Rubber Park India (P) Ltd. shall, without prejudice to any other right or remedy, be at liberty to forfeit 100% of the said earnest money as aforesaid. Further the bidders shall not be allowed to participate in the rebidding process of the Purchase and will be blacklisted.
14. The intending bidders shall ensure that the equipment offered are fully met with the guaranteed technical specifications mentioned in the tender and submit the technical specification compliance undertaking as per Annexure-1 along with the bid.
15. The intending bidders have to quote their corresponding item rates in schedule of quantities along with the price bid. The quoted price will be considered as all-inclusive rate inclusive of cost of transportation, packing, freight and insurance charges, all overheads, contingencies, profits, taxes (ie. Income tax etc.), duties/ levies, loading and unloading charges etc. for supply of the equipment at the Pump House of Rubber Park India (P) Ltd, located at Irapuram, Ernakulam but only exclusive of GST. The rates quoted by the Contractor shall be firm throughout the contract period and there shall be no upward revision of the rates quoted by the Contractor for any reasons whatsoever.
16. The successful bidder on receipt of the Letter of Award/Purchase Order, shall deposit an amount equal to 5 % (Five percent) of the contract value, as Performance Guarantee in the form of DD in favor of the Managing Director, Rubber Park India (P) Ltd. payable at Valayanchirangara within 7 days from the date of purchase order/letter of award and the Performance Guarantee will be retained till 90 days after the expiry of the Warrantee /Defect liability Period. On completion of Warrantee/Defect liability Period, the Engineer-in-Charge of Rubber Park shall recommend on demand from the bidder/Contractor to refund to him the Performance Guarantee and the same will be refunded/ released by the Accepting Authority provided that the Engineer-in- Charge is satisfied that there is no defect/liability outstanding against the bidder/contractor. All the deposits of EMD, performance guarantee will not bear any interest whatsoever.
17. The bidder shall Warranty for all items supplied against any defect arising out of faulty design or workmanship or defective material for a period of 12

months from the date of supply of item at the site. The bidder shall submit the warranty certificate along with the equipment in favour of the Managing Director - Rubber Park India (P) Ltd.

18. This notice inviting Tender shall form a part of the contract document. The successful bidders / contractor, on acceptance of his bid by the Accepting Authority shall within 7 days from the date of purchase order/letter of award, sign the contract consisting of the notice Inviting Bid, all the documents including additional conditions and specifications, if any, form part of the bid and the rates quoted at the time of submission of bid and acceptance thereof together with any correspondence leading thereto.
19. If the successful bidder fails to complete the supply in time specified, he shall, without prejudice to any other right or remedy available under the law to the Government on account of such breach, pay as agreed compensation the amount calculated at the rates 1% per week or part of the week on the total contract value of the order subject to a maximum of 10% of the contract value. The successful bidder shall not be liable for delays in performing his obligations resulting from any force majeure cause as referred to and/or defined below.

Force majeure is herein defined as any cause which is beyond the control of the Contractor or the Owner as the case may be, which they could not foresee or with a reasonable amount of diligence could not have foreseen and which substantially affects the performance of the Contract, such as:

- a. Natural phenomena, including but not limited to floods, droughts, earthquakes and epidemics;
- b. Acts of any Government, domestic or foreign, including but not limited to war, declared or undeclared, priorities, guarantees, embargoes.

Then upon the happening of any such event causing delay, the contractor shall within 07 days give notice thereof in writing to the authority, but shall nevertheless use constantly his best endeavors to prevent or make good the delay and shall do all that may be reasonably required to the satisfaction of Rubber Park India (P) Ltd, to proceed with the supply.

#### 20. Payment Terms for Supply & Installation

Payment shall be released within 15 days after successful delivery of the total item as per the schedule of quantities along with the factory test report and invoice. Date of delivery of the items in good condition at Rubber Park will be considered as date completion of supply. The GST portion of the invoice would be released only after reflection of GST amount in our GSTR 2B.



## 21. Technical Specification of the Pump Set

### A. Technical Particulars

- i) The pump shall be supplied along with drive motor, Base plate/frame along with required isolations, Coupling, and other accessories as required.
- ii) The design, manufacture and performance of the pump shall be complied with the latest version of the IS:6595: Horizontal Centrifugal Pumps for clear, cold and fresh water.
- iii) The pumps shall be capable of developing the required total head at rated capacity (the design head and discharge should have a margin of 2.5% to allow for deterioration in performance in due course of time) for continuous operation.
- iv) The pump shall be **centrifugal Horizontal Split Case** type capable of delivering the rated flow at rated head as specified in the guaranteed technical particulars.
- v) The pump shall be provided with seals of proven type as per standards. The shaft shall be supported on heavy duty ball/roller bearings.
- vi) A common base/frame plate (epoxy coated) shall be provided for pump assembly & Motor and the same shall be rigidly constructed, adequately braced and provided with finish pads for mounting pump.
- vii) The pump shall have a stable head curve, i.e. the total head capacity shall be continuously rising towards the shut off.
- viii) The pump shall have a coupling of adequate size, designed for full load and capable of supporting start –Up an overload moment.
- ix) The Pump coupling motor and base frame shall be supplied in assembled condition. Any items supplied loose shall be assembled by the Bidder at site without any implication.
- x) The pumps shall be capable of starting with discharge valve fully open and close conditions.
- xi) The Pump casing may be radially split. The casing shall be of robust construction. Casing drain and vent connections shall be provided.

- xii) The impeller shall be made out of Bronze and the material compliance certificate shall be provided along with the supply of the items by the bidder.
- xiii) The motor shall be totally enclosed fan cooled squirrel cage type and with class 'F' insulation winding.
- xiv) The motor shall be rated for continuous duty as per IS:325 and shall be suitable for operation on 415 volts +/- 10% volts, 50 +/- 5% Hz AC supply.
- xv) The Motor shall be provided with cable box to receive aluminum conductors XLPE insulated PVC sheathed and armored cables (25 mm<sup>2</sup>) without additional cost.
- xvi) Provision for earthing shall be provided for the pump, motor and base plate/frame.

NOW THEREFORE THIS PRESENTS WITNESSED AND IT IS MUTUALLY AGREED AS FOLLOWS:

1. In consideration of the said contract amount to be paid at the time and in the manner set forth in the conditions, the Contractor shall upon and subject to the conditions of the contract, execute and complete the supply in the described specifications and schedule of quantities at the agreed rates.
2. The “RPIPL” shall pay the Contractor, the Contract Amount or such other sum that may become payable at times and in the manner hereinafter specified in the said conditions.
3. The said conditions thereto shall be read and constructed as forming part of this agreement and the parties hereto shall respectively abide by and submit themselves to the said conditions and perform the agreement on their part respectively in the said conditions.
