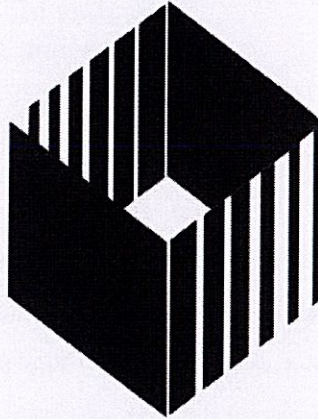

- **Quantum of work:** The blinds shall be fixed on thirteen (13) numbers of windows of the office building. The total area covered by the blinds shall be measured on completion of the installation work for payment.
- **Period of Completion:** Work shall be completed within 15 days from the date of work order.
- **Warranty:** The bidder should give 24 months comprehensive warranty for the items from the date of satisfactorily completion of installation.
- **Terms of Payment:** Payment within 10 days against satisfactorily completion of installation and submission of GST invoice.



- **Taxes:** GST at applicable rates shall be extra. GST portion of the invoice would be released only after reflection of GST amount in our GSTR 2B.
- **Rate:** The rates include cost of all materials, labour charges for installation, fittings, transportation, loading, unloading etc., at our office, Rubber Park, Piravanthur, Kollam District
- **Validity:** The bid shall remain open for acceptance for a period of Sixty (60) days from the date of opening of the quotation.
