7. Earnest Money Deposit (EMD) amounting to Rs.5,000/- (Rupees Five thousand only) to be remitted in the form of DD in favour of Managing Director, Rubber Park India (P) Ltd payable at Ernakulam. EMD of the unsuccessful bidders will be refunded without any interest on finalization of the contract with the successful bidder or on the expiry of the firm period of tender plus 30 days whichever is earlier. EMD deposited with the client will be forfeited/encashed under the following circumstances.

8. The bid submitted is treated as invalid if the bidder does not submit all the documents (as stipulated in the bid document).
9. The Managing Director, Rubber Park India (P) Ltd., does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.
10. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable for

rejection.

11. The competent authority on behalf of Managing Director, Rubber Park India (P) Ltd. reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.
12. The contractor shall not be permitted to bid for supply if he/she is the near relative of an officer of Rubber Park India (P) Ltd.
13. The bid for the supply shall remain open for acceptance for a period of 60 days from the date of opening of bids. If any bidder withdraws his bid before the said period or issue of Purchase order, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to Rubber Park India (P) Ltd., then Rubber Park India (P) Ltd. shall, without prejudice to any other right or remedy, be at liberty to forfeit 100% of the said earnest money as aforesaid. 14. The intending bidders shall ensure that the equipment offered are fully met with the technical specifications mentioned in the tender.

16. completion of warranty period, the Engineer-in-Charge of JJMRC shall recommend on demand from the bidder/Contractor to refund to him the Performance Guarantee and the same will be refunded/ released by the Accepting Authority provided that the Engineer-in-Charge is satisfied that there is no defect/liability outstanding against the bidder/contractor. All the deposits of EMD, Security deposit / Performance guarantee will not bear any interest whatsoever. During DLP, if the contractor does not attend the complaints BG will be forfeited and work will be arranged through other agencies and the contractor will be blacklisted.

17. The successful bidder shall guarantee the Electronic densimeter with liquid density kit against all defects arising out of faulty design or workmanship or defective material for a period of 12 months from the date of installation and commissioning. The bidder should submit the warranty certificate along with the certificate in favour of the Managing Director, Rubber Park India (P) Ltd.
18. The successful bidders / contractor, on acceptance of his bid by the Accepting Authority shall within 7 days from the date of purchase order, sign the contract consisting of the notice Inviting Bid, all the documents including additional conditions, specifications and drawings, if any, form part of the bid and the rates quoted at the time of submission of bid and acceptance thereof together with any correspondence leading thereto.
19. If the successful bidder fails to complete the supply on or before the contract, he shall, without prejudice to any other right or remedy available under the law to the Government on account of such breach, pay as agreed compensation the amount calculated at the rates 1.0% per week or part of the week on the total contract value, subject to a maximum of 10% of the contract value. The successful bidder shall not be liable for delays in performing his obligations resulting from any force majeure cause as referred to and/or defined below.
Force majeure is herein defined as any cause which is beyond the control of the Contractor or the Employer as the case may be, which they could not foresee or with a reasonable amount of diligence could not have foreseen and which substantially affects the performance of the Contract, such as:
 - a. Natural phenomena, including but not limited to floods, droughts, earthquakes and epidemics;
 - b. Acts of any Government, domestic or foreign, including but not limited to war, declared or undeclared, priorities, guarantees, embargoes.



Then upon the happening of any such event causing delay, the contractor shall within 15 days give notice thereof in writing to the authority, but shall nevertheless use constantly his best endeavors to prevent or make good the delay and shall do all that may be reasonably required to the satisfaction of Rubber Park India (P) Ltd, to proceed with the supply.

20. The orders or circulars issued on technical and financial matters by the Government shall stand automatically incorporated in the tender document issued subsequent to such circulars/orders.

21. Payment Terms for Supply & Installation





1.
