## 2. Scope of Work:

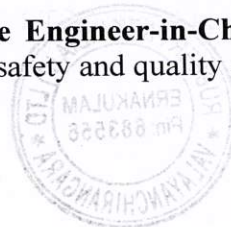
The scope of work shall include **supply of required spares, replacement, installation, testing, and commissioning** for restoring the Air Compressor (Make: Ingersoll Rand, 18 CFM at 7 Bar) to full operational condition and servicing as per OEM standards. The work shall be carried out at JJMRC, Rubber Park, Irapuram, and shall cover, but not be limited to, supply of required spares and replacement of the following:

- Bearing Set
- Piston Assembly – HP
- Piston Assembly – LP
- Tune-up Kit
- Cylinder – LP Top
- Cylinder – HP Top
- Cylinder – Bottom
- Piston Ring – Bottom

Any other components required for seamless operation.

- A. General servicing of the Air Compressor as per OEM standards.
- B. Calibration, testing, and trial run of the machine to ensure performance meets the intended operational parameters.
- C. Final commissioning of the Air Compressor in fully operational condition.
- D. Submission of documentation, including spare parts specifications, and commissioning reports.
- E. Each bidder shall visit and inspect the faulty machine to thoroughly understand the issues and familiarize themselves with the machine condition, as well as the scope, quantities, and nature of the work, before submitting their quotation.
- F. No claims for additional charges shall be entertained on account of any oversight, misunderstanding, or lack of proper site assessment by the bidder.

All work shall be carried out **as per the directions of the Engineer-in-Charge**, using best engineering practices and ensuring compliance with relevant safety and quality standards.



### 3. PRICES

- A. The Rate quoted shall be inclusive of all taxes and duties inclusive of transportation, insurance charges, all overheads, contingencies, profits, taxes (ie. Income tax etc.), duties/ levies, etc., for the **Supply of spares, Repair and Servicing of Air Compressor (make: Ingersoll Rand, 18 CFM at 7 Bar) at JJMRC, Rubber Park, Irapuram, Ernakulam District**, as per the technical specifications, excluding GST.
- B. The *prices should be stated in figures as well as in words*. In case of any discrepancy between the two, the amount written in words will be taken as correct.
- C. The rate quoted shall be firm throughout the period of contract. Price variation cannot be accepted.

### 4. VALIDITY

- A. The bid for the works shall remain open for acceptance for a period of thirty (30) days from the date of opening of the Quotation.

### 5. RIGHT OF ACCEPTANCE

- A. Rubber Park reserves the right of rejecting any or all the bids wholly or partially without assigning any reasons whatsoever.

### 6. DOCUMENTS TO BE SUBMITTED

### 7. WARRANTY

- A. The bidder should give warranty of 01 Year comprehensive warranty for the work and for the materials from the date of supply, Installation and Commissioning. The bidder shall submit the warranty certificate in favour of the Managing Director – Rubber Park India (P) Ltd.

### 8. TIME OF COMPLETION OF WORK

- B. The time of completion of the work will be 20 (Twenty) days from the date of work order. If there is any delay in, completion of the work, penalty @ 1% on the contract value per week subject to a maximum of 10% will be recovered from the Contractor.

### 09. TERMS OF PAYMENT

- A. The Payment for the supply of required spare parts, installation and commissioning shall be released on successful commissioning of the equipment within 10 days against the submission of GST invoice and satisfactory completion of the works as well submission warranty certificate. The GST portion of the invoice would be released only after reflection of GST amount in our GSTR 2B.

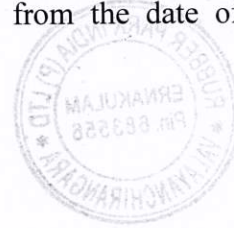

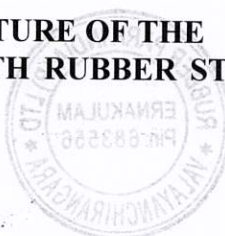

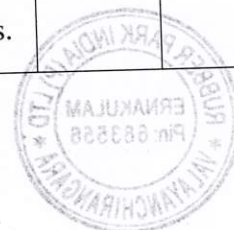
